CANCELLATION OF LESSONS BY STUDENT

The Student may cancel tuition by giving at least 24 hours prior notice to the Teacher in which case no tuition fees will be incurred. Lessons not attended by the student without giving 24 hours prior notice to the teacher shall be charged at the full rate.

CANCELLATION OF LESSONS BY TEACHER

The teacher may cancel lessons by giving 24 hours prior notice to the Student in which case no fees shall be incurred. Where a lesson was pre-paid, the teacher shall reschedule the appointment at a time agreeable to both parties, failing which the Student shall be refunded with such a missed lesson fee.

LATE ARRIVAL

Fees are calculated according to the times stipulated in the schedule and no adjustment shall be made for time lost because of late arrival by the Student.

Any lost time because of the late arrival of the teacher shall be compensated for by extending a lesson by mutual agreement and by such amount of time that was lost.

OBLIGATIONS OF THE TEACHER

* The Teacher undertakes to do all preparation prior to lessons and to structure lessons in such a way as to optimize time to the benefit of the Student.

* The Teacher shall keep confidential all information of the Student and shall contact other parties involved in the education of the Student only if given written permission by the Student to do so.

* The Teacher shall not assign any of his/her duties or obligations under this lessons contract to a third party without the written permission of the Student.

OBLIGATIONS OF THE STUDENT.

* The Student agrees that assignments, exercises or homework form an integral part of lessons and undertakes to complete such work timely.

NO WARRANTIES

The Teacher makes no promises or warranties with regards to a Student's performance as a result of any lessons provided.

STATUS OF THE TEACHER

It is expressly understood that the Student retains the services of the Teacher as an independent contractor and not as an employee. The Teacher shall be responsible for his/her insurance and for all statutory declarations and contributions with regard to income tax.

TERMINATION

This lessons contract may be terminated by either party at any time by giving the other party (2) Two days prior written notice.

RELAXATION OF TERMS

No relaxation, indulgence, waiver or release by any party of any of the rights in terms of this agreement on one occasion shall prevent the subsequent enforcement of such rights and shall not be deemed to be a waiver of any subsequent breach of any of the terms.

WHOLE AGREEMENT

This agreement constitutes the entire understanding between the parties with regard to the subject matter thereof and the parties waive the right to rely on any alleged expressed or implied provision not contained herein. Any alteration to this agreement must be in writing and signed by both parties.

MINORS

Where the Student is a legal minor, the Parent/Guardian shall enter into this lessons contract on behalf of the Student and shall accept and agree to all the terms and conditions contained herein on behalf of the Student.
